## **NOTICE OF RACE & ENTRY FORM**

### **1. RULES**

The regatta will be governed by the rules as defined in the *Racing Rules of Sailing*. The sailing instructions are common to the waterfront regattas and will be circulated under the banner of the Dun Laoghaire Combined Clubs. (Please retain them for subsequent Club Regattas in 2014.)

### **2. ELIGIBILITY & ENTRY REQUIREMENTS.**

### **3. ENTRY FEES.**

Cruiser Class 0, 1, 2 and White-sail Cruisers ECHO only - €50 add IRC 2014 + €10

Cruiser Class 3a, 3b (including Puppeteers) ECHO only - €45 add IRC 2014 + €10

Beneteau 31.7 One Design - €45 add ECHO + €10

Sigma 33, Shipman, SB20, Dragon, Glen, Ruffian, Beneteau 21, Etchell, - €45

Howth 17, Flying Fifteen, Squib, Mermaid, 2-Person dinghy - €30

Laser / Laser Radial, International Moth, 1-Person dinghy - €15

Water Wags – Included in payment of Class membership.

### **4. HANDICAPS and DIVISION of CLASSES.**

Fleets will be divided on the following basis (subject to the committee's right to allocate a boat to any class):

White-sail Cruisers shall conform to the DBSC class requirements.

Boats in other Cruiser Classes will be divided on the basis of their ISA Standard ECHO Reference Handicap.

#### **Class TCF Range**

Cruisers Class 0 1.045 and above

Cruisers Class 1 0.980 to 1.044

Cruisers Class 2 0.920 to 0.979

Cruisers Class (3a, 3b) 0.919 and lower

Boats with ratings lower than minimum rating of the class above them may participate in that class but such boats shall accept the minimum rating of that class.

### **5. ADVERTISING**

Participants may be required to display the sponsor's logo on their boats during the Regatta.

### **6. ASHORE**

*All Owners, Skippers and Crew will be Honorary Members of the DMYC on the day of the Regatta. This privilege may be withdrawn at the discretion of the committee.*

*Prize giving will take place at approximately 18.00.*

*There will be a barbecue (outside, weather permitting) and entertainment, after sailing.*
